PURPOSE OF THE REPORT

For Council to consider providing approval to proceed to call for tenders for a new Medical Services Contract. It is proposed that the new contract will be for an initial 3 year term, with a 3 year right of renewal.

BACKGROUND

At the May 2021 ordinary meeting, Council resolved as follows:
