PURPOSE OF THE REPORT

For Council to consider providing approval to proceed to call for tenders for a new Medical Services Contract. It is proposed that the new contract will be for an initial 3 year term, with a 3 year right of renewal.

BACKGROUND

At the May 2021 ordinary meeting, Council resolved as follows:

COUNCIL RESOLUTION

Moved: Cr K House

Seconded: Cr S Hmeljak

0521.59 That Council:

- 1. Adopts the delegation of some of its powers to the Audit and Risk Committee, and to the CEO as outlined in the Delegation Register attached to this report which provides a written record of Council's delegations as required by the Local Government Act (1995) and forms a part of this report.
- 2. Requires the CEO to ensure that any sub delegation to employees is in writing and pursuant to those identified in the Delegation Register adopted in (1).

CARRIED BY ABSOLUTE MAJORITY: 8/0

In the adopted Shire of Gnowangerup Delegations Register, s1.2.5 Expressions of Interest and Tenders for Goods and Services, paragraph 2.1 states:

Council delegates its authority and power to the Chief Executive Officer to:

2.1 Call tenders for goods or services with others in respect to supply of goods or services exceeding \$250,000 [F&G r.11(1)] up to max \$600,000.

Therefore, should a tender potentially exceed \$600,000 in total value, Council is required to provide approval to call for tenders.

COMMENTS

In order for staff to commence preparation of tender documents and proceed to a call for tenders for the new Medical Services Contract in compliance with the Shire of Gnowangerup Delegations Register, Council is requested to provide approval to proceed.

It is proposed that the tender will be published in December 2021 with a closing date in late January 2022.
