We are one of the few local governments operating three separate waste sites, and the long-term sustainability of this model is constantly under review. Waste management is a challenging issue for council and we rely heavily on responsible usage of the three facilities by our community. Therefore your cooperation and care when disposing of waste make a significant difference.

Council does not meet in January, but we will be holding a Strategic Planning Day later in the month. If you have suggestions, ideas, or feedback, please reach out to any of your elected members or send us an email so your thoughts can be considered.

Merry Christmas to all, and I look forward to seeing you in the New Year.



Update from the Chief Executive Officer - David Nicholson



The November council meeting included appointment of independent members to the Shire's Audit and Risk Improvement Committee (ARIC). Appointment of independent members is a significant initiative and a reflection of council's commitment to good corporate governance. While having independent members will be a requirement under the State Government's industry reform agenda, declaration of effective date is still some time away, so we are well ahead of requirements.

The Shire's ARIC independent members will be Renata Paliskis as Presiding Member, and Emily Onn as Deputy Presiding Member. Both Renata and Emily have significant audit, risk and governance experience with Renata holding similar roles for many years with other organisations, and Emily holding corporate roles and being legally qualified.

On Monday 17 November I attended a meeting in Perth with the WA Country Health Service (WACHS) as part of a Medical Alliance we've involved in. The Alliance comprises six Great Southern / Mid-west local governments who all have a similar issue – we all financially support our local GP.

For us, ratepayers contribute approximately \$350k pa to have a local GP, and it is our view (as is the Alliance's) that this cost should be borne by the State / Federal Government. This issue is heightened when you consider our local hospital's only doctor is the doctor the Shire pays for!

In addition, not only do our ratepayers have to pay for their doctor through their rates, but they also must pay when they see the doctor, and we all pay Medicare levy to support the medical system. In other words, our ratepayers pay three times to have a doctor. Just think about the stink this was cause if this was the case in a capital City.

Clearly there is an inequity in this model and we've been advocating for this to be fixed for a couple of years – hence the trip the President and I did in June to Canberra, and the meeting with WACHS in Perth. We still have a long way to go, but it's not an issue we're not about to drop.

Projects that the Shire is involved in with Voluntary Region of Councils (VROC) are making traction. These include the Great Southern (GSDC) Housing Strategy, Water for the Future Project, and Regional Infrastructure Audit. These are all big-picture strategic projects that will provide long-term benefit but will take several years before the community sees results.

Over the past few weeks, the Shire's management team have been sitting through presentations from ReadyTech, a software provider who specialise in Enterprise Resource Planning (ERP) software systems. ReadyTech supports the Shire's existing ERP (Synergy) but have advised the industry that from 2030 they will commence the process of no longer supporting this platform.

In its place they have developed a new system but moving from the old to the new will not be a simple exercise. This of course assumes we will be staying with ReadyTech which is an unknown until we go through the procurement process. While 2030 is still a few years away, as the ERP is critical to the Shire's ability to operate planning must start well in advance.

On Monday 2 February 2026 the Shire is holding its annual electors meeting. This is being held in the Gnowangerup Town Hall, commencing at midday. An agenda will be released in the new year.

Western Power prepared for summer season

Extreme heat and severe weather are not confined to the summer months and so while summer is just around the corner, we've been working year-round to ensure the network is prepared for the impact these conditions can have on electricity supply.

Every year Western Power undertakes a \$1 billion comprehensive package of maintenance programs and bushfire mitigation works to prepare the network for extreme weather events.

Prolonged high temperatures, summer storms and bushfires can have a significant impact on the network, which is why we do everything we can to prepare, delivering key upgrades and mitigation works which increase the resilience of our network.

These works include comprehensive maintenance of poles and wires, as well as bushfire mitigation programs such as network inspections and timely condition remediation, adjustments to switching patterns to manage demand, and vegetation management near power lines.

Reliability continues to be a key focus for our business, especially considering the complex and increasing challenges of climate change impacts and extreme weather events.

"Demand on our network during summer is continually increasing – over the last two summers we've experienced the top 10 highest demand days in the history of the network," Western Power Executive Manager Asset Management Gair Landsborough said.

"While 100 per cent reliability can never be guaranteed, we do everything we can to maintain reliability of 99.92% even with the increasing demand.

"We know outages over summer can be inconvenient and uncomfortable, and our targeted year-round works programs are aimed at minimising the chance of outages occurring. We work to ensure we have additional resources where required and mobile specialist staff along with emergency response generators where possible.

We're constantly enhancing our capacity to respond to emergency events, adopting a cloud-based emergency management solution, bringing us in line with DFES and WA Police, increasing our inter-agency cooperation with organisations like the Department of Fire and Emergency Services, and working closely with the Bureau of Meteorology to obtain detailed weather briefings to prepare for unique extreme weather conditions that impact our network.

"To address impacts of extreme weather events, we've increased our emphasis on disaster preparedness, customer communications and network maintenance, innovation and investment, including integrating new technologies to improve network reliability and resilience, and on-going bushfire management," Mr Landsborough said.



“This includes targeted investment in programs such as undergrounding of the overhead network and proactive asset inspections and network enhancement.”
