Discussion regarding the question taken on notice:

Gerald Slee

Ongerup is a mess. The Shire employee who does the maintenance has other work to do. The costs for the maintenance of the Ongerup Parks & Gardens seems to be too high in comparison to Gnowangerup.

CEO Bob Jarvis

It is planned to have a big annually clean up before the Wildflower show and another clean up at the start of each calendar year to take the pressure of the Shire worker and to keep Ongerup clean.

Jamie Spencer

Jamie Spencer suggested to engage a contractor / designated gardener who lives in the Shire and is responsible for all three towns.

CEO Bob Jarvis

The Shire will look into this idea.

7. GENERAL BUSINESS

7.1 Landfill Ongerup

CEO Bob Jarvis / Manager or Works Yvette Wheatcroft

The old landfill holes will be filled and the new holes will be constructed with a new improved plan.

New waste facility (Tip) gates will come into operation on Monday 22nd February 2021 for the Gnowangerup, Borden and Ongerup sites. Access to these facilities will be by Swipe Card. Each property (owner) will receive a card. Shire staff will come to Borden and Ongerup to issue the cards so they don't have to travel to Gnowangerup.

7.2 Councillor Bus Tour

Jan Slee questioned if it would be possible for the Shire to organise a Councillor bus tour to Ongerup so they have a firsthand view of the assets and problems.

CEO Bob Jarvis

Bob Jarvis advised that a bus tour is planned for the 10th March 2021 for the Councillors to have a look at the assets in the Shire of Gnowangerup including Borden and Ongerup.

7.3 Complaints Register

7.4 North Stirling Pallinup Natural Resources (NSPNR)

Jamie Spence

Jamie Spence introduced himself as the new Chair of the NSPNR and asked to give a presentation in an upcoming Council Meeting.

Bob Jarvis welcomed the idea and invited him also to the upcoming Water Strategy meeting on 18th February 2021 at the Shire's Office.

FOOTNOTES

Voting:

- Each elector present at the meeting is entitled to one vote on each matter to be decided, but does not have to vote.
- All decisions are to be made by a simple majority vote.
- Voting is to be conducted so that no voter's vote is secret.

Definition of the Elector

An elector is defined in the Local Government Act 1995. An elector is a person who is eligible to vote in an election of the Shire of Gnowangerup. For the purpose of meeting of electors, the definition of an elector is to include ratepayers.

Procedures at Electors Meetings

The procedure to be followed at a general or special meeting of electors is to be determined by the person presiding at the meeting.
